POLICE REPORT

PURCELLVILLE, Va. August 20, 2015 —

8/13/2015 - 1:24a.m. 400 Blk. Crosman Ct. **Crisis Intervention Call**

Police were called to the scene of a person that was suffering from Post-Traumatic Stress Disorder (PTSD). The person was taken into custody and taken to a mental health facility after consulting with Loudoun County Mental Health.

08/15/2015 – 3:55p.m. 100 Blk. Purcellville Gateway Dr. **Animal Complaint**

Police were contacted about a dog left in a vehicle with the temperature well above 80 degrees. The dog was removed from the vehicle with moderate distress and placed in a safe environment. The dog owner was cited with a violation.

The complainant reported that a lawn ornament had been stolen sometime overnight. The value of the item (“metal frog”) was \$175.

The incident is under investigation by the Loudoun County Sheriff’s Office Criminal Investigations.

Police were contacted by a concerned citizen about the welfare of two small children that were in a fast food establishment and were not being properly cared for by a parent. Contact was made with the parent and no

immediate concern was noted but the incident was forwarded to Loudoun County Child Protective Services to follow-up with the parent to provide possible family services.
