PURCELLVILLE, Va. September 3rd, 2015 —

08/29/2015 – 2:56p.m. 100 Blk. N. 16th St. **Crisis Intervention Call**

Police were called to the scene of a person that was having some mental health issues. On police arrival, the person was found to be in a stable mood, and after consulting with Loudoun County Mental Health, was given resources to follow-up for treatment. The person did not meet the criteria to be taken into custody.

A family member contacted police advising that her two sons were arguing and possibly fighting. On police arrival, the situation was calm. No assault(s) took place and one of the involved parties left the scene.
